This proposal requests authorization for the levy of a millage upon real and tangible personal property for the purpose of providing funding to the Shiawassee Area Transportation Agency so that Township residents can utilize the public transportation at a reduced charge. It is estimated that the Township may receive approximately \$9,000 in the first year if the millage is approved.

Shall New Haven Township levy up to 0.1463 mills (\$0.1463 per \$1,000.00 taxable value of real and tangible personal property) each year on an ad valorem basis, for a term of two (2) years (2024, 2025 tax year)?
